EVERY ENTRY AT A RECOGNIZED SHOW SHALL CONSTITUTE AN AGREEMENT AND AFFIRMATION THAT THE PERSON SIGNING IT, ALONG WITH THE OWNER, LESSEE, TRAINER, MANAGER, AGENT, COACH DRIVER, RIDER AND THE HORSE: (1) SHALL BE SUBJECT TO THE CONSTITUTION AND RULES OF THE ASSOCIATION, THE MHC, AND THE LOCAL RULES OF THE SHOW; (2) THAT EVERY HORSE, RIDER, AND/OR DRIVER IS ELIGIBLE AS ENTERED; (3) THAT THE OWNER AND ANY OF HIS REPRESENTATIVES ARE BOUND BY THE CONSTITUTION AND RULES OF THE NEHC/MHC/BOB-LYN STABLES AND THE SHOW WILL ACCEPT AS FINAL THE DECISION OF THE HEARING COMMITTEE ON ANY QUESTION ARISING UNDER SAID RULES AND AGREE TO HOLD THE SHOW, THE NEHC, THE MHC, AND BOB-LYN STABLES, THEIR OFFICIALS, DIRECTORS AND EMPLOYEES HARMLESS BY ANY ACTION TAKEN; (4) THAT THE OWNER, RIDER/DRIVER AND ANY OF THEIR AGENTS OR REPRESENTATIVES AGREE TO HOLD THE NEHC, MHC, BOB-LYN STABLES, THE SHOW, AND THEIR OFFICIALS, DIRECTORS, EMPLOYEES AND AGENTS HARMLESS FOR ANY INJURY OR LOSS SUFFERED DURING OR IN CONNECTION WITH THE SHOW, WHETHER OR NOT SUCH INJURY OR LOSS RESULTED DIRECTLY OR INDIRECTLY FROM THE NEGLIGENT ACTS OR OMISSIONS OF SAID OFFICIALS, DIRECTORS, EMPLOYEES OR AGENTS OF THE NEHC, MHC, BOB-LYN STABLES OR THE SHOW. MANAGEMENT RESERVES THE RIGHT TO DECLINE OR REFUSE ANY ENTRY WITHOUT BEING LIABLE FOR COMPENSATION, AND ELIMINATE FROM FURTHER COMPETITION ANY EXHIBITOR OR HORSE SHOULD THE BEST INTEREST OF THE SHOW BE SERVED. EVERY EXHIBITOR OR HIS AGENT AND TRAINER MUST SIGN AN ENTRY BLANK IN THE EVENT OF HIS/HER FAILURE TO DO SO, HIS/HER FIRST ENTRANCE INTO THE RING SHALL BE CONSIDERED AS HIS/HER ACCEPTANCE OF THE RULES OF THE SHOW INVOLVED AND OF THE NEHC AND MHC AND SHALL IPRO FACTO RENDER HIM/HER SUBJECT TO SAID RULES.

1. Judges' decisions are final. **Anyone wishing to speak with a judge must first obtain permission from the show steward**
2. Show management reserves the right to further cancel, combine, or divided classes when deemed necessary to facilitate the smooth running of the show.
3. Every class offered herein is covered by the rules and specifications of the current MHC/NEHC rule books and will be conducted and judged in accordance therewith
4. Trophy and/or cash plus 6 ribbons will be awarded in each class unless otherwise noted.
5. **Pre-entries close the day before the show.** Post entries will be charged a \$10.00 per animal the day of the show.
6. **All returned checks will be charged a \$25.00 surcharge fee IN ADDITION to any bank fees charged by the show's bank.**
7. Refunds of entry fees will not be made unless a veterinarian or a doctors certificate is presented to the show office no later than the day of the show. Refunds will be made for classes that are canceled.
8. Every animal entered for competition will be under control of the Horse Show Committee; but the Bob-Lyn Stables, the MHC and the NEHC and any of its employees will in no case be responsible for any loss or damage that may occur. It shall be a condition of entry that each exhibitor shall sign the entry blank holding the show blameless for any loss, accident, or decision which may occur. First entrance into the ring as an exhibitor shall be construed as his/her acceptance of the rules of the show, should the exhibitor fail to sign entry blank.
9. **All holds must be approved by the show manager.** Please let us know when the hold has been lifted!
10. All dogs must be on a **leash!**
11. MHC and NEHC membership applications available on line and at the secretary's booth.
11. A **\$50.00 fine** will be levied to anyone mucking out a trailer onto the show grounds.

### Directions:

#### FROM BOSTON/ROUTE 128:

Rte. 95 North to Exit 58A, Rte 110, Salisbury. At lights, turn left. At next set of lights, turn left. Go approx. 1 mile & stable is on left.

#### FROM ROUTE 495 NORTH:

Rte. 495 joins Rte. 95 North. Take first exit, Exit 60, Rte. 286. At lights, take right. Bear right at the next set of lights, go approx. 1 mile & stable is on left.

#### FROM PORTSMOUTH AREA:

Take Rte. 95 South to Exit 60, Rte. 286 & follow directions above.
